END-USER LICENSE AGREEMENT FOR "Tools4D Additional Effectors Vol1".

„Tools4D Additional Effectors Vol1“ hereafter referred to as the SOFTWARE PRODUCT.

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:

Paul Everett End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Paul Everett for the Paul Everett's software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation "Tools4D Additional Effectors".
